**ONLINE/TELEPHONIC INTERVIEW FOR TEMPORARY ENGAGEMENT OF**  
**SPECIALIST DOCTORS, GDMO DOCTORS, NURSING SUPERINTENDENTS, LAB ASSISTANTS AND**  
**HOSPITAL ATTENDANTS AT CENTRAL HOSPITAL LALLAGUDA**

In view of Public Health Emergency due to COVID-19 pandemic, South Central Railway invites applications through email/whatsapp from former Government Medical officers/Paramedical staff of Central/State Government/former Railway employees and "Open Market" candidates for utilising their services in Quarantine/Isolation wards exclusively for COVID-19 patients at Central Railway Hospital Lallaguda, Secunderabad for a period of three months purely on temporary basis.

**II. How to apply:** Eligible candidates are advised to send the scanned copies of prescribed application along with required documents on age proof, educational qualification, experience etc., in pdf format in one bunch to [engcmpparamedscr@gmail.com](mailto:engcmpparamedscr@gmail.com)/ WhatsApp Number 9701370624 on or before 15.04.2020. The online telephonic interviews will be conducted from 18.04.2020 onwards.

**III.** After scrutiny of the application received, the same will be shortlisted by the nominated committee based on the Educational/Technical Qualifications and experience in the relevant field. Candidates to the extent of 1:3 of the number of vacancies only will be interviewed through whatsapp video call.

**IV. Terms and Conditions:**

1. The vacancy position may increase/ decrease as per administrative necessity. There may be waitlisted/stand by candidates who may be engaged in order of merit when there is necessity.
2. The selected candidates have to work in COVID wards.
3. In case of non-availability of Specialist, vacant posts of Specialists will be filled by GDMOs. First preference will be given to former Railway Doctors.
4. **Experience: Candidates applying for the post of Hospital Assistants should possess experience of working at least for one year in a medical facility having at least 20 bed indoor facilities.** For all other categories the candidates with experience will be given preference. Candidates while applying should indicate past service rendered, if any including the period of contract put in by them on Indian Railways.
5. As the engagement is done on a temporary measure for a period of three months, the rules regarding communal reservation shall not be applicable. Hence, same selection criteria would apply to all candidates.
6. Engagement on Contract basis of the candidates will be subject to their being found suitable in order of merit by Selection Committee. The candidates selected will be placed on panel and will be sent for Medical Test as per rules.
7. The decision of the office of undersigned in all matters relating to eligibility, acceptance or rejection of the applications, penalty for false information, selection, allotment of posts to selected candidates will be final and binding on the candidates and no enquiry or correspondence will be entertained in this connection. Candidates who submit fake certificate for securing eligibility, shall be liable for rejection of his/ her candidature for the particular post for which he /she has applied besides being taken up as per common law for attempt to forgery.
8. Contract Medical Practitioners/Para-Medical Category Candidates who enter into contract with the Railway will not have any claim or right for his/ her continuity in service or automatic extension of the term of contract services or will not have any right in respect of considering of their contract period in regular selection through Railway Recruitment Board etc., nor will it confer any right for regularization or absorption. The contract can be terminated by giving 15 days on both the sides. Railway administration reserves the right to terminate the contract at any time during the contract before completion of Three months period by giving 15 days notice or payment of 15 days remuneration without assigning any reason whatsoever.
9. The selected candidates fulfilling the above conditions will be called on Recorded WhatsApp conference call interview as per above programme.
10. The original document verification of only selected candidates will be done and in case of any discrepancy in the documents, the next candidate in the panel will be considered for engagement.
